Establish Voting District Boundaries for Blair and Christopher Schools

THE GENERAL SUPERINTENDENT OF SCHOOLS RECOMMENDS THE FOLLOWING:

Establish voting district boundaries for the Blair Special Education Facility and the Walter S. Christopher School, pursuant to Paragraph 34-2.1c of the SCHOOL CODE OF ILLINOIS.

For the purpose of local school council elections, beginning in 1991, the referenced section of the SCHOOL CODE provides, in pertinent part, that the Board shall establish a voting district for each multi-area school, taking into consideration the following criteria:

- i) Previous local attendance area, if any
- ii) Physical characteristics in the surrounding geographic area, including but not limited to, expressways, rapid transit, railroad rights-of-way, rivers, and viaducts
- iii) Established neighborhood and community area boundaries established for other elected offices
- iv) Size of student population, and
- v) Compactness and contiguity of voting district.

LSC REVIEW:

The legal requirements were transmitted to each subdistrict superintendent who was responsible for recommending boundaries for multi-area schools within that district in collaboration with the school staff and local school council members. Blair and Christopher were not included in the original list. Notices were posted in each multi-area school, sent home with each child enrolled in the Blair and Christopher, and reported in neighborhood newspapers.

Public testimony was heard relative to the Blair and Christopher School on October 7th and October 9th. Attachment A incorporates the changes that were recommended and approved by the Reform Implementation Committee as a result of those hearings.







**ESTABLISH NEW LOCAL SCHOOL COUNCIL COMMUNITY VOTING DISTRICT
FOR THE TED LENART REGIONAL GIFTED CENTER**

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

Effective immediately, establish new Local School Council (LSC) community voting district boundaries and rescind the current LSC community voting boundaries for the Ted Lenart Regional Gifted Center located at 8101 South LaSalle Street.

DESCRIPTION: This change is made necessary by the relocation of the Lenart Gifted Center from 8445 South Kolin Avenue, to 8101 South LaSalle Street. This change will enable citizens residing in the area surrounding the school to be represented in the Lenart Local School Council. The current Lenart voting district boundaries were established in 1991 via Board Report 91-0917-ED1, "Establish Voting District Boundaries for Multi-Area Schools." Pursuant to law, a public hearing regarding the proposed new Lenart Regional Gifted Center LSC community voting district boundaries was held on January 7, 2004.



**ADJUST THE ATTENDANCE BOUNDARIES OF DRUMMOND, BURR, PULASKI AND BRENTANO
ELEMENTARY SCHOOLS
RESTRUCTURE AND RENAME THE DRUMMOND ELEMENTARY SCHOOL AND ESTABLISH
LOCAL SCHOOL COUNCIL VOTING BOUNDARIES**

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

Restructure and rename the Thomas Drummond Elementary School, located at 1845 W. Cortland Street, as the Thomas Drummond Montessori Magnet school, establish its Local School Council voting boundaries, and adjust the attendance boundaries of the Drummond School, the Jonathan Burr Elementary School, located at 1621 W. Wabansia Avenue, the Pulaski Fine Arts Academy, located at 2230 W. McLean Avenue and the Brentano Math & Science Academy, located at 2723 N. Fairfield Avenue.

A Public Hearing was held on April 22, 2005 at the Board Offices located at 125 S. Clark discussing the proposed boundary changes and proposed LSC voting boundaries.

DESCRIPTION:

Adjust the attendance boundaries of the Thomas Drummond Elementary School, located at 1845 W. Cortland Street, the Jonathan Burr Elementary School, located at 1621 W. Wabansia Avenue and the Pulaski Fine Arts Academy, located at 2230 W. McLean Avenue.

Adjust the attendance boundary of Brentano Math & Science Academy located at 2723 N. Fairfield Avenue. This adjustment will not affect any currently enrolled students but is necessary in order to more accurately describe the school boundary by following street center lines.

Effective July 1 2005, restructure and rename the Thomas Drummond Elementary School as the Thomas Drummond Montessori Magnet School and implement the Montessori program for grades pre-kindergarten through first grade only. Thereafter, expand the Montessori program by one grade each year until the year 2010 when all grades pre-kindergarten through sixth grade will utilize the Montessori program. Establish the Drummond Montessori Magnet School's Local School Council boundary.

While the Montessori program is implemented grade by grade over the next 5 years, current students in grades that do not yet offer the Montessori program will continue their enrollment at Drummond.

The new Thomas Drummond Montessori Magnet School shall enroll students for those grade levels offering the Montessori program citywide by application. In the event that the number of eligible applicants exceeds the school's enrollment capacity, applicants shall be selected by lottery.

The new Thomas Drummond Montessori Magnet School will offer a Montessori model of education beginning with the pre-primary level (preK) through the elementary 2 (4th-6th grades) level. The classrooms in this model of education are multi-age classrooms. The Montessori curriculum presents an integrated approach that unifies the separate branches of the curriculum into studies of the physical universe, the natural world and the human experience. Literature, mathematics, the arts, writing, history, social sciences, civics, economics, environmental studies, cosmic education and the sciences all complement one another in the curriculum. Learning occurs in an inquiring, cooperative, nurturing atmosphere. Students increase their own knowledge through self and teacher initiated experiences. The criteria for teacher selection at Thomas Drummond Montessori Magnet School shall reflect the content of the new curriculum.

Adjust the Attendance Boundary for Burr Elementary School (Unit 2530):

Effective July 1, 2005 Burr Elementary School will serve grades kindergarten through eighth:

Beginning at Damen Avenue and Cortland Street
East to the Chicago River
Southeast to North Avenue
West to Ashland Avenue
South to Pierce Avenue
West to Wood Street
South to Milwaukee Avenue
Northwest to the Starting Point.

Adjust the Attendance Boundary for Pulaski Fine Arts Academy (Unit 5520):

Effective July 1, 2005 Pulaski Fine Arts Academy will serve grades kindergarten through eighth:

Beginning at Western Avenue and Logan Boulevard
Northeast to Diversey Avenue
East to the Chicago River
Southeast to Cortland Street
West to Damen Avenue
South to Milwaukee Avenue
Northwest to Wabansia Avenue
West to Leavitt Street
South to North Avenue
West to Western Avenue
North to starting point.

Adjust the Attendance Boundary for Drummond Elementary School (Unit 3120):

Effective July 1, 2005 Drummond elementary will serve grades second through eighth, thereafter, effective July 1 of successive years, Drummond elementary will no longer serve the lowest grade. By July 1, 2010 Drummond elementary will no longer serve neighborhood students:

Adjust the Local School Council voting district boundaries of Near North Elementary School pursuant to 105 ILCS 5/34-2.1c.

DESCRIPTION:

The Illinois School Code allows the Chicago Board of Education to adjust the Local School Council voting district boundaries of multi-area schools at intervals of not less than ten (10) years. The Local School Council voting district boundaries of Near North Elementary School, a multi-area school located at 739 North Ada Street (739 North and 1332 West), have not been adjusted since their adoption on September 17, 1991 (Board Report 91-0917-ED1). The adjustment of the existing Local School Council voting district boundaries of Near North Elementary School is warranted because the school is now drawing students from a much larger geographic area than its original boundaries.

The Near North Elementary School Local School Council voted at its meeting of Thursday, September 10, 2009, to recommend the Local School Council voting district boundaries described below. Pursuant to prior notice, a public hearing to receive public comment on the proposed voting district boundary changes was held at the school on November 23, 2009.



**ADJUST THE LOCAL SCHOOL COUNCIL COMMUNITY VOTING DISTRICT BOUNDARIES OF
FRANK W. GUNSAULUS ELEMENTARY SCHOLASTIC ACADEMY**

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

Adjust the local school council community voting district boundaries of Frank W. Gunsaulus Elementary Scholastic Academy pursuant to the Illinois School Code.

DESCRIPTION:

The Illinois School Code, 105 ILCS 5/34-2.1c, allows the Chicago Board of Education to adjust the local school council community voting district boundaries of multi-area schools at intervals of not less than ten (10) years. The current local school council community voting district boundaries of Frank W. Gunsaulus Elementary Scholastic Academy, a multi-area school located at 4420 South Sacramento Avenue (4420 South and 3000 West), were established on September 17, 1991 (Board Report 91-0917-ED1). The adjustment of the existing local school council community voting district boundaries of Gunsaulus Scholastic Academy is warranted because the school is now drawing students from a much larger geographic area than the original boundaries.

On May 13, 2009, the Gunsaulus Scholastic Academy Local School Council voted to recommend the local school council community voting district boundaries described below. Pursuant to prior notice, a public hearing to receive public comment on the proposed voting district boundary changes was held at Gunsaulus Scholastic Academy at 12:00 p.m. and 3:00 p.m. on November 9, 2011.

Effective immediately, the local school council community voting district boundaries of Gunsaulus Scholastic Academy shall encompass the geographic boundaries set forth below:

42nd Street (4200 South) on the North
47th Street (4700 South) on the South
Drake Avenue (3532 West) on the West
Western Avenue (2400 West) on the East

The new voting district boundaries will include both sides of the boundary streets.
